From IEC/EN 60934 9.3 Test of indelibility of marking The test is made by rubbing the markings by hand for 15 s with a piece of cotton soaked with water and again for 15 s with a piece of cotton soaked with water and again for 15 s with a piece of cotton soaked with petroleum spirit. Decision:	On the other hand, it is very difficult to find one aliphatic solvent which is in compliance with this requirement, as this value is not always mention in the data sheet or it is very difficult to obtain from the supplier. Which aliphatic solvent has to be used in order to guaranty the correct kauributanol value, for the test of indelibility of marking? Aliphatic solvent hexane having both the main composition required by the standards and CAS No. 110-54-3 is acceptable.						
Explanatory notes:	Kauributanol value of the aliphatic solvent hexane used by various Testing Laboratories is systematically not available, unknow or not mentioned in the data sheets of the supplier. A further discussion on the characteristics of the aliphatic solvent hexane used by various Testing Laboratories, product reference included, revealed the existence of a specific Chemical Abstracts Service Registry Number (CASRN 110-54-3) specifically referred to a chemical product (n-Hexane) which should fulfil the composition generally required by the standards. OSM/IN decided also to report this practical situation to IEC/TC 23, CLC/TC 23E and CLC/TC 213.
